Following the film, enter the historic upper area on a self-guided tour through the Blacksmith, Slave Quarters, Greenhouse, Outbuildings and beautifully decorative Upper Garden. Then make your way to the famed mansion for your guided tour. Built in 1735 by George Washington's father, Augustine, at 11,028 square feet and 21 rooms, it is known to be one of America's most iconic homes. Your tour of Mount Vernon reveals a unique picture of the colonial American life. Located just footsteps from the historic estate, you'll enjoy a lunch of classic American favorites in the colonial inspired setting of the **Mount** Vernon Inn Restaurant.
